# EQUASS Excellence auditor training, Amadora, Portugal on 1-2-3 October 2013



On 1, 2 and 3 October 2012, 21 professionals from 6 different countries participated at the auditor training for EQUASS Excellence. The auditor training was offered at the premises of Fundação AFID

Diferença in Amadora, Portugal. The training was carried out according a new format based on the EQUASS Excellence 2012:

- A theoretical part with information about the EQUASS Excellence standard, the guidelines for scoring the performance of the applicant based on a self-evaluation document and the preparation of the site visit.
- A practical part with information about a real case which should be assessed and

a site visit that should be prepared by an auditor team of two persons.

Calibration of performance of the auditor teams.

All participants have contributed to preparing the training by sending in advance their individual preparatory works. During the training participants received feedback about their individual performances and the work in the smaller groups by comparing facts, figures and graphics. This facilitated the discussions and the calibration session.

The evaluation figures (average score of 4,5) showed that the new format of the training with a variation of lecturing, case study, practical exercises and discussions, was highly appreciated by all participants. Also the hospitality of AFID has been highly appreciated.

## EQUASS Assurance auditor training, Tallin, Estonia on 10-12 December 2012

On 10, 11 and 12 December 2012, 15 participants attended a training in the requirements of auditing to be followed through the whole EQUASS Assurance 2012 process.

The training, hosted in the offices of Astangu, EQUASS's Licence Holder for the EQUASS Assurance certifications in Estonia, contained the following topics: Fundamentals of EQUASS system, case study, bench marking and bench learning, calibration of experiences and requirements for verifying performance and reporting of results. The overall quality of the training was evaluated as 4,6 out of 5 by the participants, with 1 meaning 'very poor' and 5 meaning 'excellent'.

For EQUASS and the local licence holder in Estonia, the added objective was to update and expand a pool of auditors for the upcoming 2013 audits. Over 30 organisations in Estonia, active in various areas of social services provision, are planning to be audited in 2013, thanks to a programme supported by the Estonian Ministry of Social Affairs and ESF funding.

## **QUALL** Conference in Vienna

On 5 and 6 November 2012, the final conference of the thematic Network QUALLL on quality assurance in Vocational Education and Training and Adult Education took place in Vienna.

Guus van Beek was invited as external expert by the Dutch National Agency for the Leonardo Da Vinci Programme. At the conference Leonardo da Vinci projects which have been selected as lighthouse project, had the opportunity to present the results.

The project EQUASS in Practice has been said to be a 'best practice project' and Andreas Tommerbakke (project leader, AVRE) and Guus van Beek (Key Expert, EQUASS) presented the results of this project and promoted the EQUASS certification programs to potential VET-providers/ stakeholders.

The experiences of the various projects were presented and exchanged in smaller international workshops. At the QUALLL conference other opportunities have been explored by investigating possible cooperation with other initiatives to promote quality assurance in the VET sector.

The attendance at the QUALLL conference leads to the initiative to exchange information and carry out a cross-reference study between EQUASS and the European Quality Mark (for VET). The cross-reference study will be finalised in the first quarter of 2013.

## **Contribution to the Slovenian Seminar**

On 25 September 2012 Guus van Beek, EQUASS Key expert presented the value of EQUASS certification for VET-providers at the Conference on Vocational Rehabilitation in Portoroz, Slovenia.

Around 160 professionals working in the Vocational Rehabilitation sector received a presentation of the EQUASS system, and the various methods for implementing a quality standard in the SSGI sector.

# Quality of Social Services EPR Public Affair event, 6 December 2012

Guus van Beek, EQUASS key expert, contributed to the EPR Public Affair event by showing how the Principles of the European Quality Framework for Social Services can be measured and how evidences of successful implementations can be provided. He emphasised the importance of measuring the Principles of the European Quality Framework by giving examples of the EQUASS certification programs. Measuring quality should be carried out by defining effective indicators which are:

European Quality in Social Services

Enhancing performance, meeting needs

*Relevant,* they show you something about the system that you need to know.

*Easy to understand*, even by people who are not experts.

*Reliable*; you can trust the information that the indicator is providing.

*Accessible data*, the information is available or can be gathered while there is still time to act.

He focused also on the challenge in identifying and defining valid indicators for measuring and the challenges in using these indicators in benchmarking. The emphasis on benchmarking fits in the nowadays trends of performance measurement and transparency. Especially in those sectors which are not so familiar with the so called 'market approach', the concept of benchmarking may increase the overall performance of the service providers and give some pressure on the cost of the delivered services to the individual. Mr. van Beek gave some examples of research on benchmarking in social healthcare and education in the Netherlands and the United States of America. Based on these examples some doubts have been shown on the usefulness of benchmarking especially in the way benchmarking is carried out and how the results are presented. He concluded that:

It is possible to measure the Principles and criteria of the European the Quality Framework for Social Services. The two EQUASS certification programs have proven to be a valuable instrument to proof the quality of the services provide by more than 450 rehabilitation service providers in 15 European countries. То measure the "quality" it is necessary to identify and to Choosing define performance indicators. and defining the indicators is the most crucial step in the process. If wrong indicators have been chosen or defined in a way that does not represent what has been indented to be measured... the consequences could be enormous.

Once defined the indicators, it is important that those who will use these indicators have a common understanding on the definition and the way the information is gathered and presented. In this case the context plays an important role in the relevance of the indicators. The way the performance is presented may create other expectations than intended.

It strongly supports the initiative to include quality requirements as a criterion in the public procurement selection processes. However, the proof for quality should be based up-to-date and clear measurable and verifiable information and assessed in an independent way.
